NATIONAL CACFP WEEK MARCH 12 – 18, 2023

The Child Adult Care Food Program (CACFP) Week is a national education and information campaign sponsored annually by the National CACFP Sponsors Association. The campaign is designed to raise awareness of how the United States Department of Education's (USDA) CACFP works to combat hunger. The CACFP brings healthy foods to tables across the country for children in child care centers, homes, and after-school programs, as well as adults in day care. Delaware will be celebrating this week as well!

Poster Challenge

Sponsor support is important in raising awareness of how the USDA's CACFP works. You can participate in celebrating National CACFP Week by submitting participants' artwork. Delaware Department of Education (DDOE) staff will select poster entries that will be showcased on the DDOE nutrition website and Department social media accounts during CACFP Week. Please provide parent/guardian permission to allow participant's ages and first names to be shared publicly. New this year, the posters will be broken down by age category. Categories are: 1 to 2 years old, 3 to 5 years old (not in school), school-age, and adult participants.

Theme

Celebrate the Rainbow!! - What is your favorite healthy meal or snack? Your poster should represent a rainbow of food.

Deadline

Guidelines

- 1. Poster should not exceed 8 ½" x 11" sheet of paper.
- 2. Participants may use markers, crayons, paint, and pencil; be creative.
- 3. Participant's artwork only (one submission per child/adult).
- 4. Include participant's age, first name only, and name of center on back of entry.
