We are raising a grandson Michael D. Santucci since he was two years old. Michael has dyslexia and ADA problems. Michael attended Baltz school from kinder garden up to second grade. Doing these years Michael could not read and meet the standards for class room learning. Doing his 1s and second grades the teachers continually marked him that he needs improvement needs improvement. They said we are not promoting Michael to the next grade, but we are just pushing him on to the next grade. Michael continue to fail on all his subjects. Although we met with all his teachers several times thru 1<sup>st</sup> & 2<sup>nd</sup> grades they recognize Michael needed special help which they didn't have the time, resources, or know how to help Michael. Gate-Way Lab School open up starting with the 3<sup>rd</sup> grade. We signed Michael up to attend Gate-Way lab and over the past 4 yrs.' Mr. Heffernan,

I'd like to let you know about my children, and why we need Gateway Lab Charter School.

I don't know where we would be without Gateway. My children were being left behind in their school. My daughter Sierra was getting in trouble a lot, and it wasn't because of behavior. It was because by the end of her lessons on Monday she knew what she was supposed to know. So Tuesday thru Friday she would pull a book out and read or start drawing. She would get in trouble because the other kids would then want to do that as well. The problem was that they had not learned everything that they needed to learn for the week. Sierra was not being challenged at all. I begged and pleaded with the school to help her, to challenge her. Their only option was to put her in

"enrichment classes". Enrichment classes were for the advanced students, they met once a week for 30 minutes. How does this change anything? We put her in the enrichment class hoping that they would help even a little while we struggled to figure what else to do. Homeschooling was a definite and very real option for us as it was for many of our friends in the area with the same or similar issues.

Towards the end of Sierra's 2nd grade year I was talking to a close friend (again) about both Sierra and Savanna's issues in public school. She told me about this charter school that had a whole different concept for teaching children. She gave me the info, and my husband and I checked out the school. I'm pretty sure I was in tears by the time I was done reading everything I could find about it. We quickly filled out the application and set up an interview.

Sierra has been at Gateway since the doors opened and Savanna is in her second year. Both of my girls are thriving in Gateway, something I never thought possible before Gateway. I think we were about a month into school in Sierra's first year when I got a phone call from Sierra's teachers. They wanted to start working on 4th through 6th grade work with her because she wasn't being challenged enough. Those were their words, not mine. Someone else saw her potential and knew she needed more.

Savanna is thriving at Gateway as well. She is learning and actually understanding not just memorizing like she was at her other school. She is no longer bullied, no longer comes home from school in tears. Her self esteem has blossomed in Gateway in a way it never would have in her other school.

We are so thankful for Gateway. In fact we love Gateway so much that I recruited our neighborhood. We have our own hub stop and now have 5 families that get on and off at our stop. We have families that can't wait for their children to graduate 2nd grade so that they can get them into Gateway. I honestly never thought that the day would come when I wouldn't have to fight with my kids every morning to get them to go to school. Now that they are at Gateway we get in trouble with the kids if we have to pick them up early!

The teachers take the time to talk to the parents, email the parents, and work with the parents to make sure each child is working to the best of their ability and being challenged. Gateway teaches our kids with art-based learning which makes it fun as well as educational for them. They are always striving for excellence with our kids, pushing them to be the best that they can be. You would never know that our school is 63% learning disabled children when you walk through it. The kids are all engaged in learning in every classroom. We are thankful beyond words for Gateway, we would be a homeschooling without them! Please take this into consideration before you turn off the light at the end of the tunnel.

This community cannot afford to lose Gateway Lab Charter School. Neither can these children and their families.

Good afternoon Mr. Heffernan,

My name is Christina Arnold and my daughter is in her first year at Gateway lab charter. She is in sixth grade and I would like to let you know a bit about her.

My Gabby has a mild left sided cerebral palsy, thyroid disease, and worst of all epilepsy. She had her first seizure at age 9. It was a tonic clonic seizure that lasted 20 minutes and she almost died in my husband's arms because she could not breathe, mind you my husband is a nurse and was just as helpless as I was. Following that seizure she was unable to do math as it took away even her ability to do algorithms. She

also lost a lot of her comprehension skills. She loved to read but could not retain all of the information she had just read. Her dcas scores prior to the seizure were a 3 in math and a 4 in reading following the seizure she had a 1 in math and 2 in reading big difference. We are in colonial school district which unfortunately is not the best district to be in especially for the services she needed. I requested that her 504 be changed back to an iep in January of 2012 it was not put in place until May of 2013...that is the first problem. Then last year she was suppose to be receiving math intervention 3 times per week, reading, 2 times per week and speech 1 time per week. From February until the end of the year in June the only service she received was speech which if you spoke to her you would know did not help much. When I questioned why her IEP was not being followed I was told her teacher was dual certified...well since she had 26 kids in her class she could not give my daughter the help she needed. My daughter failed every subject except science and I was not even aware of this until her report card came in the mail after school let out. She was bullied and made fun of for years at the school which I reported several times and nothing was done. She became very introverted. She hated school, had no friends, and would sit and cry every night trying to do her homework. She was not being given the education she needed and deserved. She was forced to go outside during recess only to be made fun of because of the way she talked and walked instead of doing what she wanted to and that was to read a book during recess...is there anything wrong with that? She could not wait to get out of that school because she knew she would not have to deal with that anymore.

My daughter is a totally different child now who loves school, loves learning, has friends and participates in after school activities. She sat and told me she does not feel different any more and that the teachers are finally helping her all this from a 12 year old. It is all because of Gateway. The teachers care about these children so much. They take the time to teach our children in the way they need to learn. My daughter in just 3 months is doing word math problems, her comprehension skills are just unreal, and she has confidence in herself again. There is nothing worse then seeing your child struggle and so sad and not being able to do anything about it. That child is gone she is herself again. She smiles again, oh and what a beautiful smile it is I forgot how beautiful it was because she never did for years. She is passing every subject. Her lowest grade right now is an 80. She is thriving in such a short time and to hear that there is a possibility this will all be taken away from her is sickening to me.

This school is amazing. They are helping these children to thrive and giving them back the confidence they have lost in the district schools by being put on the backburner. They are learning. Go to the school and walk around you will see how

amazing it is. I left there the first time I toured with tears knowing this is where she needed to be, that they could teach her, they could give her the time and education she deserved.

This school is not just a school it is a family that cares about these children. I looked at many schools for her and I looked at the testing scores. What I saw was low numbers but that were improving year by year. I truly believe that all they need is time to show how much these children are learning. The other charter schools were given time and could not prove this to the board and I understand that, but this is the first time we are up for renewal. Please support our children. Please do not let them go back into the system to be made to feel different and not get the help they need. Sixty percent of these children have IEPs and another I believe nine percent have 504s. Please give them a chance. Please do not let my daughter and all the other children who are thriving in this school have the confidence they have gained knowing they can learn taken away. Please if at all possible go to the school take a tour. I have no doubt you will feel the same way my husband and I felt when we left. Please do not let them revoke this charter. All we need is some time and that is all we are asking for.

I hope you will not support any decision to revoke the charter of this amazing school. They have given my daughter something that she was unable to receive in our district school, an education.

Good Morning-

I am writing to you as a teacher of students who have had the opportunity to become part of the Gateway Lab School community. It is with great concern that I write this email, having heard that because of low test scores the charter for Gateway is going to be revoked. As educators and professionals of the field, basing the success or failure of a school on its test scores is not only unfair, but also misleading. The population of the school is one, that based on the very core ideals of the school, that it would be illogical to look at test scores as any indicator holding such merit of a school.

The students in Gateway are the very students that need the more focused attention and programs that are offered to them there. The students I have had in the past that attend(ed) Gateway were/are successful because of the way the program centers around the specialized needs of these students, in an environment they can feel secure in to challenge themselves and make mistakes. belittle or under value those successes in favor of a number on a matrix is a slap in the face to the very philosophies we are critiqued on with every evaluation and walk-through we are given. No one success or failure should determine the fate of student or the professionals that work with them. As a concerned teacher and parent I strongly urge you to reconsider the revocation of the charter for the Gateway Lab School. Valuing student successes is far more important an indicator than any number on a standardized test would ever show. Thank you for your time and consideration to keep the Gateway Lab School open to those students who so desperately need it.

Dear Secretary Murphy,

It has come to my attention that the renewal process, Charter School Accountability Committee has recommended Gateway Lab School be slated to close at the end of this school year 2014-2015. This is of great interest to me because I am the parent of a child whom attends this school. This proposed closure directly impacts not only my daughter, but every student and future students of Gateway Lab School.

Gateway Lab School serves a very specific student population. These students have not been able to perform well academically in a traditional inclusive public school setting. In the nearly four years my daughter has attended Gateway Lab School, she has learned to read and write on grade level, has dramatically improved her attendance, and is meeting her IEP goals.

My daughter came to Gateway at the age 10, unable to read kindergarten level material, little to no writing abilities and very basic, first grade math skills. Even though she was not meeting her IEP goals and showing insufficient progress in learning and retaining basic skills; Mt. Pleasant Elementary School, in the

Brandywine School District, promoted her each year "based on her size", and "how she would fit in with younger smaller children." Her attendance at this "traditional public school" was sporadic, because of long stays at residential treatment centers constantly interrupting instruction. My daughter was given basic accommodations to assist her in her learning, and any additional accommodations that were hard won by her father and I battling constantly to acquire them, were only causally provided. My daughter was in danger of never achieving even a basic education that she is legally entitled to.

Gateway Lab School has changed my daughter's future. She no longer is consistently absent because of hospitalization, on the contrary, she has not been hospitalized since her enrollment at Gateway. Her medications have been reduced by half, she no longer suffers from the major symptoms of her disability, and her symptoms no longer interfere with her instruction. She no longer has behavior issues and is meeting developmental milestones appropriate for her age. She loves school, she loves learning, and she loves the feeling of success and the empowerment that knowledge brings. She has learned to look to the future and make goals for her future, she wants to attend college. This is something we never thought she would be able to even think about.

Mr. Murphy, I ask that you give Gateway Lab School the three years that you mentioned. You said in three years we would be meeting proficiency. It has also come to my attention that Gateway Lab School has been granted the alternative framework designation, but not for this year. This is very unfortunate. I must repeat that we need more time! Mr. Murphy please grant us the three years you said we needed to meet our proficiency. Gateway Lab School is making a difference now and for the future of not only the students but for their families, future employers and our communities. Great students equal stronger communities and economic growth. We need this school and more schools like this.

I believe in this school, this issue. Thank you for your consideration.

Alison: We have some comments to make on the proposed closing of Gateway Lab School by the DOE. We are hoping that you will be able to get this email to the proper person or persons prior to the hearing in December.

Over the past several years, we have had the opportunity to observe and participate in activities with the students and staff at Gateway. The staff there is dedicated, capable and goes far beyond the normal to educate the students in their care.

Stating that scores are low and unacceptable is a rather broad statement when almost 2/3 of the student population is learning disabled. Many of the students are unable to sit and test and understand the directions even though they have had complete directions.

A new math curriculum was written and approved by the state this past summer. It has just recently been introduced to the students. Scores do not improve immediately, and we feel that Gateway needs more time to see the benefits of the new curriculum. The school is young, and is just ready to turn the corner if given more time.

We have also had the privilege to attend one of the newly introduced afterschool clubs. The students are learning and growing in the area of both science and math while participating in the Fishing Club. It is amazing to watch students measure, calculate and ask great questions of the staff with them. Other new clubs formed are Music Composition, Hiking and Math League. All of these add to the special needs of the students and provide an alternative learning experience.

Many of the Gateway students are only able to learn by alternative methods. These



are provided so well at the school, and the staff is very, very committed to treating each child as an individual in their learning process.

Please give Gateway more time to continue what they have started. Do not base your decision on scores but on the alternative learning which is going on at the school. The students are truly blessed to have such a wonderful staff working to help make them responsible adults.
