At the December 18, 2014 meeting of the State Board of Education, the application to renew the charter of Reach Academy for Girls ("Reach") was not approved. The current charter for Reach is in effect until June 30, 2015.

Notwithstanding the non-renewal decision, the Department of Education requests the cooperation of Reach in continuing to provide your students with a quality education and maintain an environment conducive to learning and instruction for students and staff for the remainder of the school year. To that end, please find enclosed a copy of the Department's Charter School Closure Protocol, which includes responsibilities of the Charter School's Board and Leader. In addition, please note that as a state entity you have the further responsibility to protect assets and official state records in your possession.

The Charter School Office will be in contact with you soon to schedule a meeting to discuss the tasks to be completed prior to June 30<sup>th</sup>. The first critical task will be to ensure that students apply to school choice prior to the close of the choice window, January 14, 2015. The Department also would appreciate your assistance with scheduling a parent meeting to take in early January to allow parents and students the opportunity to learn about other educational options. ➤ This section contains any information gathered during the pre-referral process including referral forms, Record of Correspondence, copies of report cards/test scores, etc. In addition, this section should contain any Permissions to Screen.

**Section 3: Permission to Evaluate**

➤ This section contains any Permission to Evaluate in descending order with the most recent one on top and the Prior Written Notice behind the Permission to Evaluate it references.

**Section 4: Eligibility**

➤ This section contains all Evaluation Summary Reports in descending order with the most recent one on top. Any medical information used to document a Physical Impairment (for example a report/letter documenting ADD/ADHD/ Cerebral Palsy, etc.) must be attached to the current Evaluation Summary Report.

## **Section 5: Current IEP Information**

➤ This section contains the original copy of the student's current IEP, Behavior Support Plan, and any transition information referenced within the document.

## **Section 6: Previous IEP Information**

➤ This section contains original copies of the student's IEPs for the previous three years in descending order with the most recent one on top.

➤ File Transition Surveys and/or SSP's behind the appropriate IEP.

## **Section VI: Current Assessments**

➤ This section contains all current assessments including psychoeducational reports, related service assessments/progress reports, outside evaluations, Functional Behavior Assessment, etc.

## **Section VII: Previous Assessments**

➤ This section contains all previous assessments from the time of the original identification ranging from psychoeducational reports, related service assessments/progress reports, outside evaluations, etc. in descending order with the most recent one on top.

## **Section VIII: Meeting Minutes/Prior Written Notice/Statement of IEP Resources**

➤ This section contains Meeting Minutes, Prior Written Notice Forms, Manifestation Determination minutes and Statements of IEP Resources Forms in descending order with the most recent one on top.

➤ Statement of IEP Resources is to be placed after the appropriate Prior Written Notice.

➤ Meeting Minutes is to be placed after the Statement of IEP Resources or after the Prior Written Notice if there is no Statement of IEP Resources for that IEP meeting.

## **Section IX: Meeting Notice**

➤ This section contains Meeting Notices and IEP Meeting Excusal Forms in descending order with the most recent one on top.

## **Section VIII: Miscellaneous**

➤ This section contains any other information including things such as Surrogate Parent documentation, Guardianship documentation, Contact Logs, letters from parents relating to the IEP, Parent Consent for Release of Information, Parent Consent to Release Information and to Access Public Benefits, etc. in descending order with the most recent one on top.

MEMORANDUM OF UNDERSTANDING  
BETWEEN  
DELAWARE PUBLIC ARCHIVES AND  
DELAWARE DEPARTMENT OF EDUCATION

### I. PARTIES INVOLVED AND THEIR AUTHORITY

The parties to this Memorandum of Understanding (MOU) are the Delaware Public Archives (DPA) and the Delaware Department of Education (DOE).

The authority of the parties involved is derived from the following statutes:

#### A. The Delaware Public Archives

The Delaware Public Archives is established as a division within the Department of State and is charged with administering, implementing and enforcing all provisions of the Delaware Public Records Law. Delaware Code, Title 29, Chapter 5, § 1.

#### B. The Delaware Department of Education

The Delaware Department of Education is given the authority and responsibility for the general administration and supervision of the free public schools and the educational interests of the State. Delaware Code, Title 14, Chapter 1. The Delaware Department of Education with the approval of the State Board of Education is further authorized to approve charter schools to operate in the State of Delaware. Delaware Code, Title 14 § 503. Charter Schools are considered public schools for all purposes. Delaware Code, Title 14 § 504.

### II. PURPOSE

This MOU between the DPA and the DOE has been jointly developed for the following purposes:

- A. To develop a uniformed process for the maintenance and handling of public records created by Delaware Charter Schools that close.
- B. To meet the needs of the two signatory agencies, the MOU will define the responsibilities of each agency.

### III. ROLES AND RESPONSIBILITIES

#### A. The DPA shall:

1. Provide necessary storage space for the records during an interim period of not more than one year after closure of a Charter School;
2. Coordinate with staff from the DOE in handling the records to ensure proper implementation of DPA's Operating Policies and Procedures for Records in Transition and Access to Records;
3. Provide assistance to the DOE with using the School District General Records Retention Schedule for the maintenance and retention requirements for all records created by the Charter School;
4. Operate as the official custodian of the closed school's records after the initial interim period of not more than one year after the closure of a Charter School; and
5. Administer the request for such records in accordance with the Operating Policies and Procedures for Access to Records.





#### B. The DOE shall:

1. Implement closure procedures of Charter Schools;
2. Provide initial oversight of all Charter School records during the initial period of not less than one year after closure;
3. Designate staff to organize and prepare the closed Charter School's records in accordance with the guidelines of the School District General Records Retention Schedule and the DPA's handbook: Records Management Handbook Preparation of Records for Short-Term Storage;
4. Administer the transfer of student records to new schools/districts if the Charter School fails to do so or if the new school is unknown at the time of closure; and
5. Verify all former employees' benefits, cumulative leave, and be responsible for servicing initial requests for Personnel Records made by other schools/districts within the initial one-year period.





### IV. REVIEW

This Memorandum of Understanding shall be effective immediately upon signing by all parties and will remain in effect until a new agreement is signed. This MOU shall be review annually by appropriate personnel for each agency and shall be reauthorized at least every five (5) years by the Delaware Public Archives and the Department of Education. Renegotiation of any portion of this MOU may occur at any time for good cause, upon written request of any of the participating agencies. This MOU may be terminated by any of the parties upon thirty (30) days written notice.
