# Structure Updates

- While revising the standards, the Leadership Team and Advisory Committee are making adjustments to the system structure that was previously shared.
- Standards will be organized into three “buckets” we’re currently referring to as Pillars. These are:
  - Creating Conditions for Quality
  - Leading for Learning & Well-Being
  - Building a Community of Care
- Each pillar will contain 2-3 standards, for a total of no more than 9 standards
- The standards will include “indicators,” (verifiable practices related to each standard) which will flow through the Star levels

## Three “Pillars” and Eight “Standards”

### 1. Creating Conditions for Quality

- Business Practices
- High Quality Personnel
- Continuous Quality Improvement

### 2. Building a Community of Care

- Relationships with Children
- Relationships with Families
- Relationships with Community

### 3. Leading for Learning and Well-Being

- Promoting Children’s Learning
- Playful Learning Environments

- We have and continue to work with the National Center for Early Childhood Quality Assurance on the revision.
- We will be hosting virtual meetings to get feedback from teachers, administrators, family child care providers, and school age programs.
