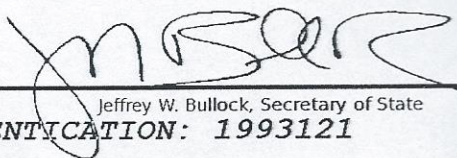

STATE of DELAWARE  
CERTIFICATE of INCORPORATION  
A NON-STOCK CORPORATION

First: The name of the Corporation is VINE'S PREPARATORY SCHOOL CORP.

Second: The Registered Agent and address of Registered Office is Dr. Chanda Jackson, 126 N. Kirkwood St. Dover, DE 19904, Kent County

Third: The purpose of the corporation is to engage in any lawful act of activity for which corporations may be organized under the General Corporation Law of Delaware.

This Corporation shall be a non-profit corporation serving a public educational purpose for students residing in the state of Delaware. The Corporation is organized and shall be operated exclusively for charitable, scientific, or educational purposes within the meaning of Section 501©3 of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future federal tax law (the Code) and in particular to operate a charter school formed and operated pursuant to Title 14 501-518 of the Delaware Code.

The Corporation may receive gifts, devises, and bequests and hold, administer, and dispose of the same exclusively for the accomplishment of the charitable purposes for which the corporation was created. The Corporation in carrying out its purposes shall have all the powers granted by law to an exempt corporation formed under the Delaware Code and laws amendatory thereof and supplementary thereto.

Notwithstanding any provision herein, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501©3 of the Code. No substantial part of the activities of the corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, except to the extent permitted by law, and the Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

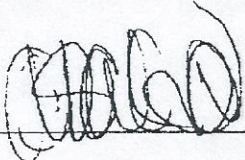
Fourth: The Corporation shall not have any capital stock.
